Who Requires a CoC for Morocco?

Manufacturers and exporters intending to ship regulated goods to Morocco are required to conduct local verification processes. They must coordinate with an Inspection Body authorized by the Moroccan government, such as Applus+, to acquire a Certificate of Conformity (CoC) before exporting their products to Morocco.

What Is the Verification of Conformity (VoC) programme for Morocco?

Recently, Morocco has made significant changes to its market access conditions. A wide range of products now must prove compliance with the country's quality and safety regulations.

To enforce this, the Moroccan authorities have established a Verification of Conformity (VoC) programme aimed at ensuring products meet current regulations. Failure to demonstrate compliance can result in shipment rejection at the port of entry.

What Products Are Covered Under the CoC Scheme?

The CoC scheme applies to a wide range of products, including but not limited to:

- Electrical appliances
- Other electrical products



- Construction materials: pipes, sheets, sanitary equipment, insulation, wooden panels, cement, windows, glass, etc.
- Gas/oil appliances
- Products for children: toys, baby baskets, diapers, furniture, etc.
- Textiles: shoes, leather goods, clothing, etc.
- Chemical products: detergents, paint, bitumen, matches, lighters, etc.
- Plastic products: plastic packaging, bags, etc.
- Products in contact with food: kitchenware, crockery, etc.
- Personal Protective Equipment (PPE): motorcycle helmets, etc.
- Automotive spare parts: tires, automotive parts, etc.
