

# Certificate of Conformity (CoC) for Saudi Arabia

The Kingdom of Saudi Arabia requires that all consignments of products covered by a **Saudi Standards, Metrology, and Quality Organization (SASO)** Technical Regulation and to be exported to the country be issued with a **Product Certificate (PCoC)** and accompanied by a **Shipment Certificate (SCoC)**. These certificates signify compliance with the applicable standards and technical regulations.

Thorough safety inspections, testing, and conformity assessments are crucial for smooth market access into Saudi Arabia. The primary focus is to ensure that products meet safety and quality standards, providing assurance to consumers that the products are safe for use.

## Who Requires a CoC for Saudi Arabia?

Exporters of regulated products intended for export into Saudi Arabia are required to meet the stipulations of pre-inspection, testing, and obtaining a **Certificate of Conformity (CoC)**. This is essential to avoid delays in clearing goods, penalties, or even the return of your shipment.

## What Products Are Regulated Under the CoC Program for Saudi Arabia?

**Regulated products** under this scheme include:

## **Construction and Building Materials**

- Metal and Their Alloys for Building and Construction
- Insulation and Building Cladding Material
- Bricks, Tiles, Ceramics, Sanitary Ware, and Related Products
- Doors, Windows, and Accessories

## **Mechanical Equipment**

- Portable and/or Hand-Oriented Machines
- Mobile Machinery and Heavy-Duty Equipment
- Auto Spare Parts
- Motorcycles

## **Textile Products**

- Textile Products
- Personal Protective Equipment and Clothing (PPEs)
- Leather Products

## **Electrical Products**

- Electric Batteries
- Electromagnetic Compatibility (EMC)
- Restriction of Hazardous Substances in Electrical and Electronic Equipment
- Low-Voltage Electrical Equipment and Appliances

## **Chemical Products**

- Food Safety in Tools and Appliances Used in a Kitchen

## **What is the PCoC and SCoC?**

The **Product Certificate of Conformity (PCoC)** is the product conformity certificate issued by an approved and accredited conformity assessment body, such as Applus+, for all registered products in the **SABER** platform. Every PCoC issued for each model is valid for **one year**.

The **Shipment Certificate of Conformity (SCoC)** is the shipment certificate issued upon client request, also through the **SABER** platform, based on an official signed and stamped commercial invoice, packing list, bill of lading, and other shipment-related documents. It is to be issued prior to shipment arrival and remains valid until all goods in the commercial invoice successfully clear Saudi customs.

## How Do I Get a CoC for Saudi Arabia?

- **Creation of Request and Submission of Required Documentation:** Via **SABER** to conduct the evaluation.
- **Evaluation of Documentation:** Provided by both client and laboratories towards the issuance of the PCoC.
- **Factory Production System Audit:** For Type 3 product category.
- **Issuance of the Report:** Based on the process results.
- **Issuance of the PCoC Certification:** Via the **SABER** portal and submission to the client.

### Step 3: Shipment Certificate of Conformity (SCoC)

- **Client Requests the Issuance of the SCoC:** Through the **SABER** platform.
- **Submission of Required Documentation:** For the shipment and technical evaluation provided by Applus+ technical team.



- **Issuance of the SCoC:** Through the **SABER** platform.
- **Process for Each Shipment:** Must be conducted for each shipment, aligned with each shipment commercial invoice/order.
